This Agreement is made and entered into by Riceland Foods, Inc., hereinafter called the "Association," of Stuttgart, Arkansas; and the contracting grower, hereinafter called "Grower."

Witnesseth:

Grower, in order to be a member of this Association, hereby agrees to the following:

- 1. To purchase one share of membership common stock... 2. To enter into a marketing agreement... 3. To make a capital contribution... 4. Grower hereby agrees to be bound by the Association's Articles of Association and Bylaws as now in effect or as hereafter amended.

5. Members may participate in both patronage and non-patronage pools all as established annually by the Board of Directors in accordance with the Association's Articles of Association and Bylaws.
6. This Agreement shall continue in force from year to year (the Association's fiscal year) unless cancelled in writing by the member or the Association prior to August 1 of any year. If a member becomes a non-producer of farm products or fails to deliver the minimum quantities of farm products as established by the Association in any year, such action shall automatically suspend all membership privileges and voting privileges hereunder.
7. The parties agree that the Articles of Association and the Bylaws of this Association, as now in effect or as hereafter amended, and the marketing agreement, are incorporated herein by reference and together with this Agreement constitute the entire agreement between the Association and the Grower. The parties further agree that there are no oral or other conditions, promises, covenants, representations or inducements in addition to or at variance with any of the terms hereof, and that the Agreement represents the voluntary and clear understanding of both parties fully and completely.
